DESCRIPTION

A very well presented two storey retail unit located on Victoria Street in the pedestrianised centre of Crewe. The property would suit a range of retail, professional services or office based businesses and has a generous sales area.

The first floor has two good sized office/storage rooms with staff toilet. The property benefits from a 3 phase electric supply, suspending ceiling, air conditioning units and a powered coated aluminium window frontage. There is the opportunity for the incoming tenant to apply for the repurposing our high streets grant, available via Cheshire East Council. Up to £30,000 is available to pay for refurbishment, equipment and a new shop front.

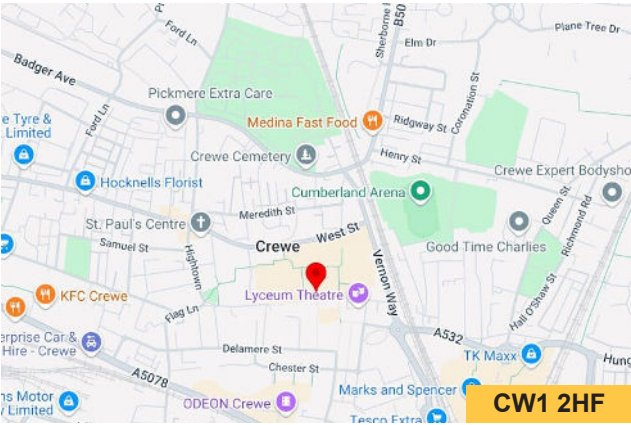
